ANNEXURE

The Permission for increase of intake from 60 to 100 seats in B.Pharm. Degree Course for the academic year 2016-17 is granted subject to the following conditions:-

- i) The admission procedure as laid down in Govt.order, Health and Family Welfare (MCA1) Department should be followed strictly. The seats available in B.Pharm. Degree Course shall be filled up as per orders in force. The Management shall follow a transparent and reasonable method of admission for the Management quota as per orders in force.
- ii)The candidates should have been admitted before the cut off date.
- iii) The Trust should agree for the Inspection of the College by the Tamil Nadu Dr.M.G.R. Medical University at any time according to the Statutes, Ordinances, Regulations and Rules for Pharmacy College framed from time to time.
- iv) The Candidates admitted will take up their I B.Pharm. Degree Examination as per the existing regulations of this University.
- v) The Trust and the Pharmacy College should abide by the Statutes, Ordinances, regulations and Rules framed by the Tamil Nadu Dr.M.G.R. Medical University on matters of syllabus, Examinations, Code of conduct, extracurricular activities, etc.
- vi) The conditions that may be prescribed by the All India Council for Technical Education, & Pharmacy Council of India, New Delhi shall be fulfilled and the rules and regulations of the central council shall be followed strictly.
- vii) The Trust should obtain the periodical All India Council for Technical Education, New Delhi approval year after year and forward the same to the University.
- viii) Only qualified staff shall be appointed to handle the classes in the B.Pharm. Degree course.
- ix) No Unqualified staff shall be appointed.

- x) Only eligible candidates according to the regulations of this University shall be admitted to the I B.Pharm. Degree Course. While making admissions, the Rule of Reservation of the Government of Tamil Nadu shall be adopted strictly.
- xi) The sanctioned strength for said Degree Course should not be exceeded.
- xii) There shall not be any financial Commitment either to the University or to the Government.
- xiii) Hostel accommodation shall be made available for the students both Male and Female separately.
- xiv) The admission of students should be made after the date of issue of this proceeding.
- xv) Required furniture shall be provided wherever they are necessary.
- xvi) Furnishing of false information to the University on any matter or suppression of facts while furnishing information to the University or Violation of any of the Statutes, Ordinances, Regulations, Rules, instructions or conditions of affiliation shall result in withdrawal of the Affiliation of the College.
- xvii) The Institution shall show evidence of an annual income of not less than Rs.4,00,000/- (Rupees Four lakes only) excluding the interest accrued from the Security Deposit mentioned in the statutes to facilitate the proper running of the proposed Pharmacy College.
- xviii) The College shall furnish a "Utilisation Certificate" to the University stating that the interest accrued on the Security Deposit has been utilised towards maintenance of the Pharmacy College.
- xix) The Trust shall have a duly constituted Governing Body with a representative of the teaching staff to advise the Principal in the affairs of the College. A record of proceedings of the said Governing Body of the College shall be maintained by the Principal.

xx) The Governing Body of the College shall meet at least once in every three months to consider the Budget Estimates and such meet in May – June each year to consider the Annual Report, the audited statement of accounts, changes in the pattern of staff, subjects or courses in which fresh affiliation or approval is to be sought in the following year, etc. A Copy of approval notice of the meeting shall be sent to the Registrar, atleast 15 days before the date of the meeting. A copy of the minutes of the meeting shall also be sent to the Registrar of this University within 15 days from the date of the meeting.

xxi) The College shall furnish a Budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the first and second year of the course of study.

xxii) The Provisional Affiliation now granted by the University is for the first year of B.Pharm. Degree Course only.

xxiii) After fulfilling all the conditions required to be fulfilled by the college under the Tamil Nadu Dr. M.G.R. Medical University by the time only six months period is left for the first year B.Pharm. Degree Course of study, the Institution shall apply to this University for the grant of Continuance of Provisional Affiliation for the second year B.Pharm. Degree Course of study.

xxix) Any other conditions which the University considers necessary to impose from time to time should be followed.
