In the Resolution No. 4(1) passed at the 277th Governing Council meeting held on 30.09.2020, it was resolved to grant CPA/CCPA without conducting inspection for the Academic year 2020-2021 to the Pharmacy Institutions after getting undertakings for the Academic year 2020-2021 alone as a one time measure due to

 COVID-19. Accordingly, the Institution was informed vide this University communication 17th cited to furnish undertakings, in this regard.
- 11. In the reference 18th cited, the Managing Trustee of the said Institution has submitted a notarized affidavits duly signed to abide by the appropriate rules regarding non conduct of regular Inspection and for non submission of DTCP approval for the Academic year 2020-2021 for issue of CPA/CCPA, as resolved in the Governing Council resolution communicated.
- 12. In the pursuance of the above, the University grants Conditional Continuance of Provisional Affiliation to J.K.K Munirajah Medical Research Foundation Annai J.K.K Sampoorani Ammal College of Pharmacy, B. Komarapalayam, Namakkal District for conducting B.Pharm., M.Pharm. & Pharm.D degree courses for the academic years 2019-2020 & 2020-2021 as indicated below subject to the usual conditions already intimated in the Provisional Affiliation orders of this University and pending submission of DTCP approval. The Institution shall arrange for furnishing DTCP approval within three months from the date of issue of this Proceeding.
