Introduction:

The seminar on Geographical Indication & Copyright For Drugs was held on April 08,09/19 at JKKMMRF's AnnaiSampooraniAmmal College of Pharmacy. The seminar was organized by the Department of Pharmacy, and a total of 350 students participated. The purpose of the seminar was to provide attendees with an introduction to the basics of Geographical Indication & Copyright For Drugs as a tool for analyzing and organizing qualitative data. At the end of the seminar, all attendees received a certificate of completion.

Objectives:

The main objectives of the seminar were to:

- It is used to identify goods having special characteristics originating from a definite geographical territory.
- Provide an overview of the different types of qualitative data and how to collect and analyze them
- Introduce attendees to the use of Geographical indication & copyright for drugs
- Provide attendees to the drug is covered under patent protection, which means that only the pharmaceutical company that holds the patent is allowed to manufacture, market the drug and make profit from it.

Participants:

The seminar was open to all students at JKKMMRF's Annai JKK Sampoorani Ammal College of Pharmacy, and a total of 350 students participated. The attendees represented a range of academic disciplines within the field of pharmacy, including pharmacology, pharmaceutical chemistry, and pharmacy practice. Most of the attendees had some experience with qualitative research, but some were new to the field.

Format:

The seminar was structured as a combination of lectures, group discussions, and hands-on exercises. The lectures were led by an experienced researcher with expertise in qualitative research and Geographical Indication & Copyright for drugs, and the hands-on exercises were led by a trained facilitator. The seminar was held over two full days, with breaks in between to allow attendees to rest and ask questions.

Content:

The seminar covered a range of topics related to qualitative research and the use of Geographical Indication & copyright for drugs. On the first day, attendees learned about the different types of qualitative data, including interview transcripts, focus group transcripts, and observational field notes. They also learned about the different approaches to analyzing qualitative data, including coding, memoing, and categorizing. On the second day, attendees learned how to use Geographical Indication & copyright for drugs to organize and analyze their qualitative data, including importing data, coding text, and creating visualizations.

Evaluation:

At the end of the seminar, attendees were asked to complete a short evaluation form to provide feedback on the seminar. Overall, the evaluations were very positive, with most attendees rating the workshop as "excellent" or "good." Attendees commented that the lectures were clear and well-organized, and that the hands-on exercises were helpful in providing a practical understanding of Geographical Indication & copyright for drugs.

Conclusion:

Overall, the seminar on qualitative research with Geographical Indication & copyright for drugs was a success. A total of 350 students participated, and all attendees received a certificate of completion. The positive feedback from attendees suggests that the seminar met its objectives and was well-received by the participants. 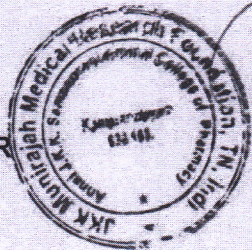





ABOUT THE TOPIC

GEOGRAPHICAL INDICATION & COPYRIGHT FOR DRUGS

Geographical Indications (or GI) are granted to identify products that bear a close association with the region or a specific geographical area, where they are found/originated/manufactured.

The protection is granted to the undertakings and establishments located in that particular area and may use the 'geographical indication' on the exclusive goods produced in such area. This allows the owners of GI to take prompt action against any potential or real violation of a registered Geographical Indication.

Geographical Indications FAQ's

Geographical Indication (GI)?

GI is an indication, originating from a definite geographical territory. It is used to identify agricultural, natural or manufactured goods produced, processed or prepared in that particular territory due to which the product has special quality, reputation and/or other characteristics.

Is registration of a GI compulsory and how does it help the Applicant?

Registration of a GI is not compulsory. Registration of a GI has the following benefits:

- **Legal protection:** This enables to IP holder to secure protection against infringement of the registered GI;
- **Exclusive rights:** Prevents unauthorised use of a registered GI by others and assures safety of individuality;
- **Demand:** Boosts exports of the registered GI products since they receive their individual identification on every legal platform and also invite media coverage;
- **Economic Growth:** Promotes economic prosperity of producers of goods produced in a geographical territory.

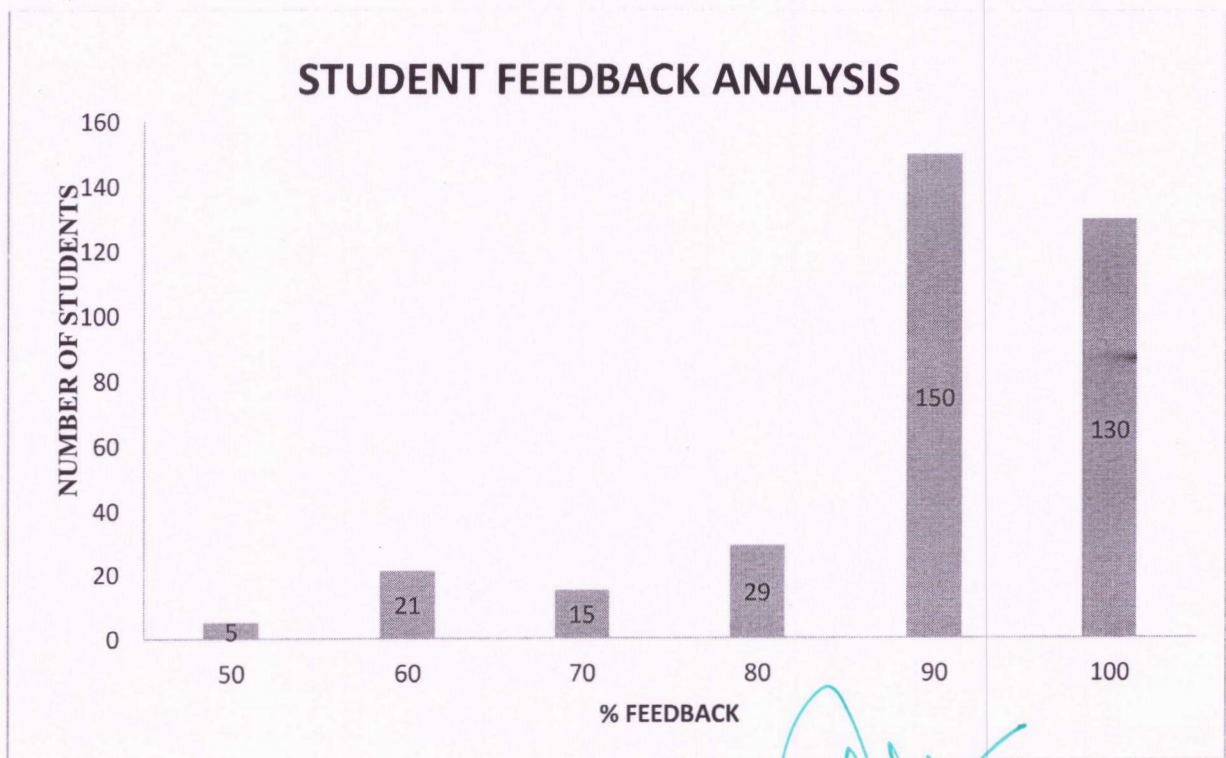
