Introduction:

The seminar on PROTECTION OF IPR FOR ENFORCEMENT OFFICIALS was held on June 28<sup>th</sup>, 2019 at JKKMMRF's Annai JKK Sampoorani Ammal College of Pharmacy. 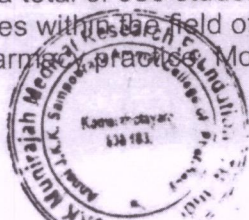
Objectives:

The main objectives of the seminar were to:

- Introduce attendees to the principles of, to create public awareness about the economic, social and cultural benefits of IPRs among all sections of society.
- Provide a to modernize and strengthen service oriented IPR administration.
- Introduce attendees to the use of PROTECTION OF IPR FOR ENFORCEMENT OFFICIALS for organizing and analyzing qualitative data
- Provide attendees with the opportunity to practice using PROTECTION OF IPR FOR ENFORCEMENT OFFICIALS through hands-on exercises

Participants:

The seminar was open to all students at JKKMMRF's Annai JKK Sampoorani Ammal College of Pharmacy, and a total of 350 students participated. The attendees represented a range of academic disciplines within the field of pharmacy, including pharmacology, pharmaceutical chemistry, and pharmacy practice. protection of IPR Enforcement, but some were new to the field.

#### Format:

The seminar was structured as a combination of lectures, group discussions, and hands-on exercises. The lectures were led by an experienced researcher with expertise in PROTECTION OF IPR FOR ENFORCEMENT OFFICIALS, and the hands-on exercises were led by a trained facilitator. The seminar was held over one day, with breaks in between to allow attendees to rest and ask questions.

#### Content:

The seminar covered a range of topics related to the use of PROTECTION OF IPR ENFORCEMENT OFFICIALS. On the day, attendees learned about the different types of qualitative data, including interview transcripts, focus group transcripts, and observational field notes, they also learned about the different approaches to analyzing qualitative data, including coding, memoing, and categorizing. Attendees learned how to use PROTECTION OF IPR ENFORCEMENT OFFICIALS to organize and analyze their qualitative data, including importing data, coding text, and creating visualizations.

#### Evaluation:

At the end of the seminar, attendees were asked to complete a short evaluation form to provide feedback on the seminar. Overall, the evaluations were very positive, with most attendees rating the seminar as "excellent" or "good." Attendees commented that the lectures were clear and well-organized, and that the hands-on exercises were helpful in providing a practical understanding of PROTECTION OF IPR FOR ENFORCEMENT OFFICIALS.

#### Conclusion:

Overall, the seminar on PROTECTION OF IPR FORENFORCEMENT OFFICIALS was a success. A total of 350 students participated, and all attendees received a certificate of completion. The positive feedback from attendees suggests that the seminar met its objectives and was well-received by the participants. The skills and knowledge gained from the workshop will be valuable to the students as they continue their studies and pursue careers in the field of pharmacy.

#### Recommendations:

Based on the evaluations and feedback from attendees, we recommend offering similar workshops in the future to continue to build capacity in qualitative research and the use of PROTECTION OF IPR FOR ENFORCEMENT OFFICIALS at JKKMMRF's Annai JKK Sampoorani Ammal College of Pharmacy. 



Protecting Intellectual Property for enforcement officials

Pharmaceutical and Medical Devices

The lack of coordination between DPIIT and the Central Drugs Standard Control Organization through either patent linkages or an effective notification system invites abusive infringing activities, which compromises the ability of innovative industries to effectively commercialize and enforce their IPR in India. Liberal price controls, coupled with the potential abusive use of procedures such as pre-grant and post-grant opposition proceedings, further complicate an effective IPR regime for the pharmaceutical and medical device industries.

Enforcement Climate

India continued to take steps against websites with pirated content. Despite positive steps taken in online copyright enforcements, such as “dynamic injunctions” for repeat offenders, copyright holders continue to report high levels of piracy, particularly online and through commercial broadcasts. This includes unauthorized file sharing of videogames, signal theft by cable operators, commercial scale photocopying, unauthorized reprints of academic books, and circumvention of Technology Protection Measures.

Technology, Brand, and Intellectual Property Licensing

The Indian government formed an inter-ministerial group to investigate reinstating royalty caps for all technology collaborations and brand licensing, limiting the amount of foreign exchange that can leave the country. If implemented, such caps would negatively affect all sectors of the economy in which a company licenses its brand name or enters a technical collaboration.
