### **Objectives:**

The main objectives of the seminar were to:

- 1. Evaluate the patentability of an invention
- 2. Decide whether to patent an invention
- 3. Prepare a patent application

### Participants:

The seminar was open to all students at JKKMMRF's Annai JKK Sampooorani Ammal College of Pharmacy, and a total of 350 students participated. The attendees represented a range of academic disciplines within the field of pharmacy, including pharmacology, pharmaceutical chemistry, and pharmacy practice. Most of the attendees had some prior experience with qualitative research, but some were new to the field.

#### Format:

The seminar was structured as a combination of lectures, group discussions, and hands-on exercises. The lectures were led by an experienced researcher with expertise in intelletual property rights and the hands-on exercises were led by a trained facilitator. The seminar was held over one full days, with breaks in between to allow attendees to rest and ask questions.

#### Content:

The seminar covered a range of topics related to Pharmacological research areas. On the first day, attendees learned about the the importance of patenting for the development and application of new technology for the benefit of society. They also learned about the different sections involved in the Indian Patent Act.

### **Evaluation:**

### **ABOUT THE TOPIC**

#### PATENTING OF BIO-INVENTIONS

### INTRODUCTION

A patent is an exclusive right granted by a government for an invention, which is a product or a process that provides, in general, a new way of doing something, or offers a new technical solution to a problem. The details on the way of acquiring patents will be provided for protecting precious intellectual properties.

### CRITERIA FOR GRANTING A PATENT

In order to be patentable, an invention must meet the following three criteria:

- a. It must be new;
- b. It must involve an inventive step(that is, non-obvious to a person skilled in the relevant field of technology); and
- c. It must be capable of industrial application.

### **USE OF PATENT**

Like the owner of any other private property, a patent owner has the right to prevent others from using it, abandon it, sell it, that is, assign it for a fee or free (gift), and allow one or many others to use it, while retaining its ownership, by 'licensing out' the patent for one or more specified purposes, during a specified time period, in one or more specified jurisdictions. Licensing is always done for a valid consideration that may be in cash or kind, as may be mutually agreed and specified in a written and formally signed license agreement.




