2. The members of the University Sports Grants Council have scrutinized each application received from the various affiliated institutions of this University for the sanction of Financial Assistance to conduct Inter-Collegiate Sports Meet for the Academic Year 2019.

3. The members of the University Sports Council have examined your application for sanction of Sports Grant and other aspects of your institution in detail and finally selected your Pharmacy College to sanction of Financial Assistance for conduct of Inter-Collegiate Sports Meet for the Academic year 2019.

4. The University will provide Financial Assistance to a maximum of Rs.1,00,000/- (Rupees One lakh only) to your Pharmacy College for the conduct of Inter-Collegiate Sport meet. Out of Rs.1,00,000/- 80% of first installment of Rs.80,000/- (Rupees Eighty thousand only) will be sanctioned as advance and remaining 20% of Rs.20,000/- (Rupees Twenty thousand only) will be released only after submission of all relevant bills / vouchers and Utilization certificate and Auditor certificate, if the amount exceeds of Rs.5,000/- (Rupees Five thousand only) must be produced stamped receipts.

5. The First installment of Financial Assistance will be released by the University based on the request received from your institution.
