
We have a separate chamber dedicated to incinerators for our Bio-Waste management system.

## INCINERATOR ROOM



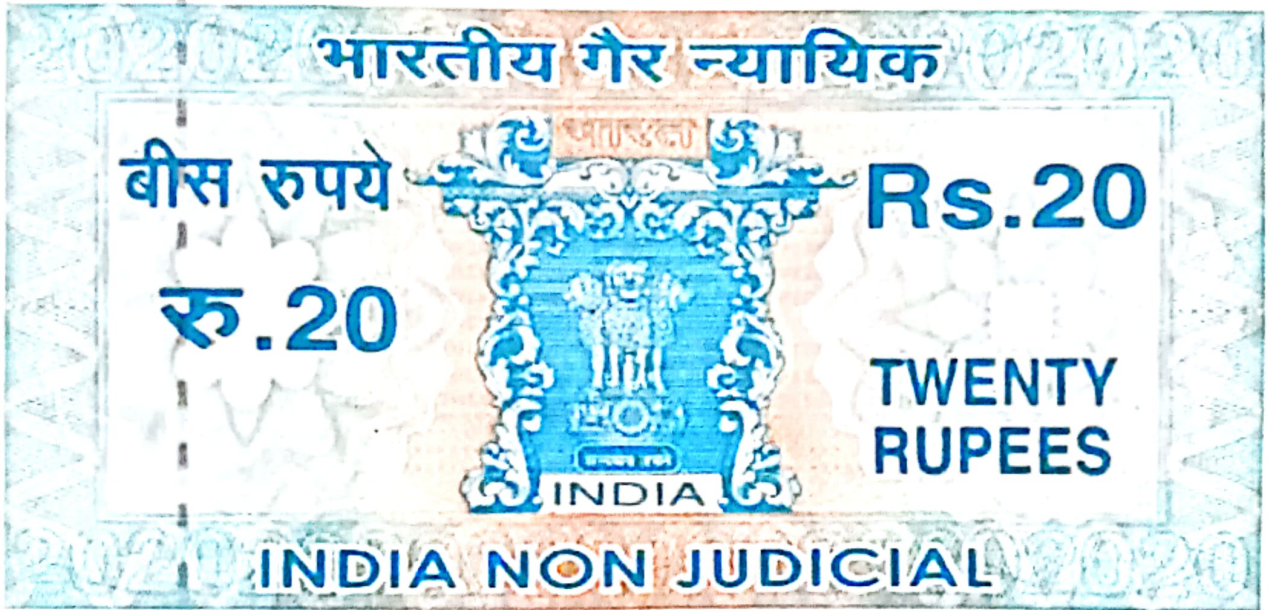




